Re: Request for Your Urgent Intervention in the Case of Jase Bouma (Exhibits Attached)

Dear Governor O'Malley,

I am Jill Jones-Soderman PHD, MSW, MSHS, Exexecutive Director of The Foundation for the Child Victims of the Family Courts, 501 (c) 3, a Not for Profit Organization.

The Foundation was retained by a relative of a now eleven year old child, Jase Bouma whose custody has been remanded by the Maryland Courts to the custody of the father whom after extensive investigation, review, research presence in court, interviews/contacts with numerous actors in this case, including the child, the child's father has brought us to certain realizations which compel us to bring these issues to your attention. The corruption and abuses of the Maryland administrative bodies, court system, attendant administrative agencies are as per our investigation and evidence placing this child's life in severe jeopardy. Further, the descriptions of the sheer daily misery and distress to which this child and his mother are being subject, all well documented would not be acceptable to the Humane Society, much less to any body of law that is acting under Constitutional authority and the spirit of the Bill of Rights.

I am enclosing for your information and review a copy of a Child Protective Services Report, and a line by line critique of that report, correcting inaccurate statements which document the unconscionable suffering of a child held against his will and welfare in Maryland. The child has been held now for more than two years in the hands of an abusive father, Mr. Jason Bouma, well known to the State. Mr. Bouma has been named frequently and vehemently as an abusive, harmful custodian of his son, Jase Bouma, that that the complaints made so often are a matter of public record, as opposed to the sealed secrets as somehow desired by the state of Maryland's Howard County Circuit and District Courts. These Courts have attempted to exact a chilling effect through this case upon lawyers, mental health workers and various others whom have mandated reporter responsibility and those of us who shed light on the widespread collusion of lawyers, court actors, mental health service professionals and others who profit from the suffering of children and targeted families. Judges and other court actors, we suspect as being in collusion appear to forget FIRST AMENDMENT RIGHTS OF FREE SPEECH, RIGHT OF CHILDREN AND THE WHISTLEBLOWER LAW.

The documented circumstances and direct pronouncements of the subject child, Jase Bouma, regarding his abuse are so clear, articulate, and demonstrable that the failure of Maryland authorities to act on behalf of the protection of this child are unconscionable, cruel, as well as unlawful. All forms of hard evidence corroborating this child's statements have been suppressed. Even an eleven year old child has a right to Due Process under the law, yet the multiple "professionals" in this case (and numerous other cases of children in which the same insidious group of actors) have profited financially at the expense of children and families have prevailed in their brutal suppression of fact and justice.

I am hopeful that before your departure from office, that at least one of the crimes current in Maryland be properly addressed and corrected. We would expect that given your review at this juncture we would hope that this child is returned to the custody of the caring parent who justifiably deserves to care for and protect her child as well as being allowed to mend the wounds inflicted by the father with the approval of state actors. The state has engaged in the suppression

of multiple pieces of hard evidence as well as actively bobbing and weaving to suppress the testimony the of highly trained, respected professionals, plus the barring of the unbiased expert witness, notable professional, internationally revered psychological expert in family dynamics and alienation, Dr. Monty Weinstein.

Your investigation and attention to the abusive acts surrounding this child's horrific situation could expedite its correction and end the misery of a child who has begged for freedom.

Appreciation for your intervention would most certainly be widely heralded.
