

MEDICAL IMMORALITY AND THE COURTS:
The Case of "Dr." Timothy Jolley, Pullup, WA

If there are members of the public who feel that they have been victimized by this pediatrician we are interested in hearing accounts of your experience.

Your information will be maintained as confidential, if requested.

We have fully documented information related to the fact that this physician has used a disputed medical license since 1984, but that the American Board of Pediatrics refuses to accept any complaints regarding his allegedly illegal medical practice, continuing into the present day. We strongly suspect that Timothy Jolley continues to be engaged in criminal and civil behavior which needs to be investigated, litigated and fully publicized.

The behaviors which have been documented include:

Falsification of psychiatric diagnoses used against a mother to support the transfer of her two young children, from the hands of the protective parent into the hands of the physical and sexual abuser.

Based on the false documentation of a letter from Dr. Jolley, two young children have been forced into the custody of the physical and psychological abuser.

Dr. Jolley quoted the name of a psychologist, stating that the psychologist had seen and diagnosed a parent with a toxic diagnosis, "MUNCH HAUSEN BY PROXY". The illusion to this diagnosis was enough to procure the transfer of custody from the protective parent to the perpetrator, the abusive parent. Both children in this person's care are in medical danger and have suffered severe neglect. The child has resisted the assaults of the custodial parent, who has complete decision making power and control. Her hospitalization and medical care are being blocked by this parent, who has chosen to have complete control of this child's life, though she has spoken out and reached out for help. Her attempts at seeking help are met with verbal assault and abuse. Professionals who have come forward to demand that this child be heard, have themselves been insulted and discredited, replaced by other fraudulent court actors, who are uneducated in the relevant areas necessary to protect this child from imminent death.

This case is before the court in Washington State, but because of the ignorance and ineptitude of the court system as to its ability to handle, much less recognize criminal behavior by an obsessed abuser, the likelihood of this child's death is significant, despite the desperate, tireless efforts of the protective parent and professionals around that parent who are mistrusted and rudely treated. Yet, the fraudulent accusations of professionals of power and wealth, though immoral and unethical, are taken as gospel.

We have documentation of significant numbers of sexually inappropriate behavior by Dr. Jolley, documented by police reports and other relevant documents.

We have documentation that the psychologist who reputedly saw the client in question, never actually saw the client, and never wrote a report providing the diagnosis given to the court, which discredited the protective parent.

We have the document of evaluation by a credible professional stating unequivocally that the client in question never suffered from the diagnosis of which the individual was accused.

The diagnosis of Munchausen by Proxy was outlawed by Congress because this extremely toxic diagnosis has been overused to remove children from the protective parent into the hands of the abuser. We have documentation that medical treatment was denied to a suicidal patient.

A patient who discussed suicidal ideation with Dr. Jolley, as per documentation in his medical notes, was denied to have discussed such ideation, though Timothy Jolley's medical letter to the court indicates that the patient was not suicidal and was denied medication, although medication was indicated.

Other aspects of medical notes were also discredited, when the patient was examined at another medical facility. The parent who is suspected of neglect and various forms of abuse, has complete control and decision-making power and we suspect has conspired with Timothy Jolley to conceal the patient's actual physical status, leading to conscious malpractice.

There is further concrete evidence in our possession of Jolley's lack of fitness to practice medicine. Some of that material includes allegations of drug, alcohol, and sex addiction, as well as criminal charges against him. All of this information is available through research of public records. Records of his treatment at various facilities for drug, alcohol and sexual abuse also exist yet are ignored by the State Medical Licensing Board and all other authorities in the medical community.

We have attempted to make the Medical Licensing Board aware of this information, as well as the Governor, but we have been met with a consistent lack of interest.
