THE FOG IN PUYALLUP, WASHINGTON APPEARS TO BE BEFUDDLING THE BRAINS OF

SUPERIOR COURT JUDGES

The telephones of the Foundation for the Child Victims of the Family Courts are answered seven days per week, twenty four hours per day.

In one evening a phone call came in from an individual who turned out to be a young teen age girl who was begging for help stating - " I have told everyone, no one listens to me, my mother will get into trouble if she says anything to help me or talk to me about the fact that my sister and I are forced by my father to have sex with my father and step brother". She related that she wanted to be with her mother, to see her mother, but was kept from all but the most limited contact with her for the past ten years. She stated that she" wanted to die" and was starving herself and expected that she would die in a matter of days. She stated that the pediatrician Timothy Jolly of Puyallup, Washington, knew that she was losing weight and that she was depressed and he refused to place her on medication. She stated that Timothy Jolley weighed her with her coat on and "things" in her pockets to make her appear heavier than she actually was and she knew that she was losing weight. This young girl dropped the phone/hung it up when she heard her mother coming into the room from where she had called. Jill Jones-Soderman dialed *69 to capture the phone number from which this girl called. She called the phone number, reached the mother and informed the mother of the discussion she just had with the daughter and stated that the mother needed to take the child to an emergency room outside of the county in which the mother resided - reason being that if the child was telling the truth - and the mother had not summoned the courage to protect her child from an individual that Jones-Soderman, a seasoned clinician suspected of being an obsessed abuser. Jones-Soderman knew that the father would have protected himself by creating allies in the community and those allies would immediately contact the father who would intervene and stop any attempt at protecting the child.

Jones-Soderman contacted "child protective services", the police and the hospital named by the mother who was a physician who was suspected of having known of her two daughter's abuse history and was suspected of having known that there was a suspected early history of sexual abuse that was covered up by the pediatrician, Timothy Jolley who has practiced for years under a limited license having received thousands of complaints against his medical license in Puyallup, Washington. The mother, a physician herself juggled the suspected abuse of her daughter's with the protection of her medical license as a general practitioner. The mother's lawyer, Jacqueline McMahon, Esq. was familiar with the abuse occurring and had been the attorney for the mother for ten years, bringing numerous actions - unsuccessfully, thus leaving the girls at the mercy of their father, so named by the older daughter who called the home "that house of horrors." McMahon made a fortune on the abuse, devastation, destruction of the girls, maintaining a sick status quo. Interestingly, McMahon withheld an affidavit written by Jones-Soderman to confirm that Jones-Soderman was contacted by the teen ager who located her via the internet and the name of the Foundation - FCVFC.ORG.

When attention was brought by Jones-Soderman to the authorities and immediate action was taken,, the father, the guardian ad litem - James Cathcart, a middle aged attorney, former Marine - accused Jones-Soderman of making "wild accusations". Let's be very clear that those "wild accusations born out to be quite true resulted in saving the life of the child - who weighed approximately 87 pounds and had a BMI of fourteen when she was taken to the hospital, evaluated and placed into protective custody and then placed into the custody of her mother. The child in question clearly stated her situation of abuse endured and held her ground in a confidential meeting held by the organization with the misapplied term -" child protective services".

The guardian ad litem, James Cathcart named as the custodian of the best interests of the child - a tattered phrase that has come to be associated with the failures of protection under the authority of those who know nothing, who understand nothing of what they are doing, yet who have the authority to destroy the lives of many. Cathcart coined the phrase "locked and loaded"; Jill Jones-Soderman was "locked and loaded" when she met with the fourteen person panel under the auspices of "child protective services and hurled wild accusations of child sexual abuse in a forum which was about to hear from a child who herself staunchly faced her father and a hostile crowd who did not want to hear the truth of the child's complaints. Further, who in their right mind would appoint a middle aged lawyer, former marine to speak to an adolescent girl about sexual issues of any form............of course the judge and the lawyers for the father. Cathcart was more concerned about impressing the father's reputedly pristine lawyer P. Craig Beetham of Eisenhower, Carlson, a misguidedly highly respected law firm as per the performance in this case in which the behavior of the lawyer in representing an obsessed abuser in a perverse caste of characters.

Cathcart's use of the phrase - "Locked and Loaded" used to attempt to insult Jill Jones-Soderman has been adopted as use by the Foundation for the Child Victims of the Family Courts; the phrase is now blazoned on tee shirts - "Locked and Loaded Against child Sexual Abuse" - THE FOUNDATION FOR THE CHILD VICTIMS OF THE FAMILY COURTS - 501 (C)3.

The mother - still first concerned for protecting her license as a physician - under attack by the father and his legal team, attorney P. Craig Beetham who had forced her to sign an unconscionable parenting plan, attacked the Director of the Foundation for the Child Victims of the Family Courts, 501 (C)3 by having her lawyer falsely state that she, Jacqueline McMahon " fired" Jill Jones-Soderman for having made" wild accusations" with regard to the child in question, when Ms. McMahon was fully aware that the child not only personally contacted the Foundation, but sent pages of her diary to Jones-Soderman and had a number of private, confidential discussions with the clinician/ Forensic Advocate who saved her life. Jones -Soderman has referred to McMahon as liar and a fraud and plans to file complaints with the Bar association against her.

"Jones-Soderman has accused McMahon of not only being an idiot, but also being a liar for having falsified conversations which never existed between herself and McMahon and having lived with the knowledge of the alleged abuse suffered by the two sisters over ten years. Jones-Soderman did in one night what McMahon had failed to do in ten years and what the mother permitted to continue, protecting her medical license over her children - but of course having been placed in this heinous

position by the Puyallup Courts and the inexplicable contention on the part of the court and other responsible authorities like the schools. Jones-Soderman did in fact contact the principle of the school attended by the reporting child and lambasted the principle for allowing the atrocities to occur that the principle had to know were going on under her surveillance. The idea that this principle should get away with being allowed to pretend that she was unaware of what was going on was" just not going to be tolerated" according to Jones-Soderman.

Jones-Soderman contacted the Puyallup, Washington medical licensing board and the Federal Bureau of Children's Affairs along with a number of other related child protective agencies. She was told by officials at these agencies whose names remain chronicled, that these agencies knew of the "bad behavior" of a number of doctors who were culpable of predatory sexual behavior toward patients and patients mothers that they simply "did not know what to do with these doctors and other individuals in prominent positions in the community". Jones -Soderman has found this statement utterly unacceptable and has taken the position of publishing, filing complaints against Judges, lawyers, guardian ad litem and all those who betray their sacred trust to their children, patients and clients.
